## Guest Student Application for Michigan State University Graduate Students

A graduate student at Michigan State University may enroll as a "guest" student at the College of Law. As a guest student at the College of Law, the student is expected to fulfill all normal course requirements. Upon successful completion of the course(s), the guest student is awarded academic credit by the College of Law. Prospective guest students may apply to the College of Law up to four weeks prior to the start of the academic term to which they are seeking admission.

The following materials are required to apply for admission as a guest law student:

- a completed MSU Graduate Student Guest application form;
- an application fee of \$20;
- a one- or two- paragraph statement describing the reason(s) for seeking admission as a guest student; and,
- authorization from the dean's office of the graduate department in which the student is enrolled.

Guest student applications will be approved upon the receipt and review of all required application materials and once a determination has been made that the applicant has the required background for the course(s). Guest students may register for classes after paying the required deposit of \$75 and after current MSU Law students have registered for the academic term. The deposit applies toward tuition charges, but is not refundable.
