Required TPI Courses

Year 1:

Pre-Trial I (3 credits) –fall 2011

Pre-Trial II (2 credits) – spring 2012

Technology Enhanced Trial Advocacy (no credit) – seven week session fall 2011/spring 2012

Advocacy as a Performing Art (1 credit) – first seven weeks of spring 2012

Year 2:

Trial I – Criminal Trial (3 credits) – fall 2012

Forensic Science (2 credits) – first seven weeks of fall 2012

Trial II – Civil Trial (3 credits) – spring 2013

Other Required Courses:

Administrative Law (3 credits) – Must be completed before graduation

Criminal Procedure I (3 credits) – Must be completed before graduation

Additional Requirements:

Attend all mandatory TPI sponsored events.

Maintain professional dress and decorum during TPI classes and TPI sponsored events.

I understand that the TPI Certificate Program requires the completion of 20 credit hours in addition to Technology Enhanced Trial Advocacy. I also understand that TPI students are required to attend all TPI sponsored events and maintain professional dress and decorum during TPI classes and TPI sponsored events. _____ (please initial)

I understand that scheduling of these classes is subject to administrative constraints. Although the needs of individuals will be considered as a part of the process, it will not be possible to accommodate every request.
